So what you're saying is that the City does not consistently abide by statutory requirements per ORS 197.763 (2)(b) and ORS 227.175 (10)(b) which detail specific activities and actions (regulations) related to the governing body and it's relationship with formally recognized neighborhood associations which were, coincidentally, established and sanctioned via the City of Oregon City. Why then would the City bother to draft a Resolution and Agreement for formal NA recognition if contractual terms are, by your own admission, not executed to legal sufficiency?

Thank you for the email to clarify if neighborhood associations are entities of the City. Neighborhood Associations are not entities of the City and the City is not responsible for their actions nor can the City regulate their actions.

The excerpt from Carrie Richter, our Assistant City Attorney, is discussing a land use application submitted by the City's Public Works Department. The Planning Commission's decision on that application was appealed by the McLoughlin Neighborhood Association. So in that case the City was the applicant before both the Planning Commission and the City Commission and McLoughlin Neighborhood Association became the appellant before the City Commission. Carrie is simply explaining the context for the City Commission to make their decision, based on the criteria, not as the applicant. Hope this helps.

BHNA Chair, Betty Mumm's, interpretation of ADA Reasonable Accommodation Requests resulted in proposed accommodation via a 'hearing amplifier' - no such device has been recognized or approved by BHNA; disabled citizen resident Michael Miller has never received the 'hearing amplifier' in a personal or public capacity nor is there any proof of accommodation via the use of city equipment (apart from the afore mentioned instance). Despite multiple requests to BHNA, no current audio recordings of public or private meetings have been uploaded by the city website or sent to the email address and/or residential address provided (see attachments - BHNA Chair Mumm Response & Miranda Sierra Response to BHNA Chair Mumm - July 2017)
