Any interested party may testify at the public hearing or submit written testimony at or prior to the close of the public hearing. **Written comments must be received at City Hall by July 15, 2016 to be included in the Planning Commission staff report.** Written comments received after this date will be forwarded to the Planning Commission at the hearing. **Written comments must be received at City Hall by August 8, 2016 to be included in the City Commission staff report.** Written comments received after this date will be forwarded to the City Commission at the hearing.
