Mayor Holladay called the meeting to order at 7:02 PM.

Mayor Holladay read a statement of encouragement during the Covid-19 pandemic.

4. Citizen Comments

There were no citizen comments.

5. Adoption of the Agenda

Item 8a was pulled from the consent agenda. The agenda was adopted as amended.

6. Public Hearings

6a. AP-19-00001: Appeal of a Planning Approval of a 2-Lot Minor Partition at 206 Holmes Lane (Planning File: GLUA-19-0015/MP-19-00002)

Mayor Holladay opened the public hearing.

Bill Kabeiseman, City Attorney, read the hearing statement and asked if there were any ex parte contacts, conflicts of interest, bias, or any other statements to declare.

Commissioner McGriff had visited the site.

Diliana Vassileva, Assistant Planner, presented the staff report. This was an appeal of the Community Development Director's approval of a two-lot minor partition on Holmes Lane. She described the subject site, partition proposal, appeal standing, issues raised by the appellant, how no new evidence should be considered, and staff recommendation for denial of the appeal.

There was no public testimony.

Mayor Holladay closed the public hearing.

There was discussion regarding the applicable criteria and nuisance weed issue.

A motion was made by Commissioner McGriff, seconded by Commissioner Lyles Smith, to deny AP-19-00001: appeal of a planning approval of a 2-lot minor partition at 206 Holmes Lane (Planning File: GLUA-19-0015/MP-19-00002) and reject the new information that came in after the record was closed. The motion carried by the following vote:

AP 20-00001: Appeal of an Approval with Conditions for a 20-lot Subdivision Located at 13735 Lazy Creek Lane (Planning file Appeal GLUA-19-00030 and SUB-19-00003)

Mayor Holladay opened the public hearing.

Mr. Kabeiseman read the hearing statement and asked if there were any ex parte contacts, conflicts of interest, bias, or any other statements to declare.

Mayor Holladay and Commissioner O'Donnell met with the applicant after the appeal had been filed, however they were not aware at the time that an appeal had already been filed.

Commissioner Lyles Smith said the application had been presented to her neighborhood association in January 2020 when she was in attendance.

Commissioner McGriff visited the site.

Laura Terway, Community Development Director, presented the staff report. This was an appeal of the Planning Department's approval of a 20-lot subdivision on Lazy Creek Lane. She discussed the subject site, proposed subdivision, application of the stormwater and grading design standards, appeal standing, planning review process, original and revised submittals, proposed revisions to the conditions and findings, documents to add to the record, and options. Staff recommended approval of the appeal with the amended conditions and findings in the revised staff report dated April 1, 2020.

Mark Dane, resident of Oregon City, was representing the applicant who was also the appellant. They had provided a solution where both the applicant and City could move forward with the final engineering drawings. He discussed the timeline of the project and unresolved stormwater issues. The appeal was used to work through the issues with revised conditions of approval that would be acceptable. They were requesting

approval of the appeal with the amended conditions.

Mayor Holladay closed the public hearing.

There was discussion regarding the change in the design, timing of the meeting with the applicant and staff, and vacation of the right-of-way.

A motion was made by Commissioner McGriff, seconded by Commissioner Smith, to approve AP 20-00001: appeal of an approval with the conditions in the staff report dated April 1, 2020 for a 20-lot subdivision located at 13735 Lazy Creek Lane (Planning file Appeal GLUA-19-00030 and SUB-19-00003). The motion carried by the following vote:

Commissioner Lyles Smith said she worked for the Department of Land Conservation and Development, but was not part of the selection process for this grant program.

A motion was made by Commissioner Lyles Smith, seconded by Commissioner Smith, to approve the Personal Services Agreement with 3J Consulting for Phase 1 of the Comprehensive Plan update. The motion carried by the following vote:
