# Oregon City Civic Improvement Trust Minutes for April 4, 2013

Mayor Doug Neeley, Chair of the OCCIT called the meeting to order at 5:34 pm. Introductions were made, roll was called and a quorum was established.

#### **Approval of Minutes:**

The minutes from October 10, 2012 joint work session with the Metro Enhancement Committee were presented for approval. The approval of minutes passed with approval from all, except Commissioner Mumm who abstained. Minutes from the 4/2/2012 grant meeting were approved on 10/10/2012.

## **Report out on OCCIT Grant Ranking:**

Mayor Neeley explained that the ranking philosophy of grant projects has changed since last year after discussions at the October 2012 work session. The committee submitted rankings for the projects prior to the meeting and each member ranked projects from 1 to 8, with a 1 being the project that they scored the highest.

## Exit Reports:

Mayor Neeley asked if there were any past projects that didn't submit an exit report. For the 2012-13 grant year we didn't receive report from the Teddy Bear parade. This project is not requesting grant funds this year.

#### Conflicts of Interest:

The mayor explained two kinds of conflict of interest: a) receives compensation; b) an individual sits on a board with interest. Trustees declared any direct or indirect conflicts of interest:

- Doug Neeley— Member on Clackamas County Historical Society, a member of the Peace Corps for three years, on the board of trustees for the McLoughlin Memorial Association, and a business member of the Oregon City Chamber of Commerce.
- Rocky Smith—teacher at Oregon City High School

- Carol Pauli—business member of the Oregon City Chamber of Commerce and City Commission representative on the board of Main Street Oregon City
- William Gifford—business member and on the government and economic affairs committee for the Oregon City Chamber of Commerce.
- Betty Mumm—member of the Clackamas County Historical Society

# **Discuss and Review Grants:**

Applicants for each of the eight grant applications came forward to provide a summary of their projects and answer any questions from the committee. There is \$60,000 available to fund projects. Representatives were as follows:

- McLoughlin Memorial Association Denyse McGriff and Mike Jarrett
- Oregon City Chamber of Commerce Karin Morey
- Oregon City High School Band and Flag Team Michelle Rizzo

- We Love Clean Rivers Sam Drevo

The Mayor proposed that the committee ask if projects could reduce their funding in order to provide some funding for We Love Clean Rivers. Main Street Oregon City was asked to the presenter's desk and asked if they could take a \$2000 reduction from their grant request. Ms. Fowler commented that while everyone is grateful for any funding they receive through OCCIT, she hoped that the committee would stick to the process and ranking system. She stated the project proposed for the First City Celebration would not be the caliber if reduced by \$2,000, and therefore would decline the requested reduction.

After further discussion, funding for the We Love Clean Rivers project was pulled from the tentative awards based on the following motion made by Betty Mumm, seconded by Carol Pauli. The motion – Recommend to the City Commission to include the We Love Clean Rivers feasibility study to be included in the Master and Visioning Plan for the Willamette Falls Legacy Project, and removed from this granting process. # **Discussion Items:**

Administrative Policy 2-11 is a policy for City committees, including the OCCIT, to report out to the City Commission at a Commission meeting. Since the OCCIT meetings are only available on the City website and not televised, the group unanimously approved to have staff report to the City Commission at a future meeting, with an emphasis that the We Love Clean Rivers project be part of the visioning process for the Falls project.

Rocky requested that it be a requirement of the OCCIT grant application that reoccurring projects ask for reduced amounts each year. A motion was made by Carol Pauli and seconded by Rocky Smith that reoccurring grant requests for the same project will only be awarded a lower amount than the previous year or will not be awarded a higher amount than the previous year, and that this requirement be reviewed by the City attorney to make sure there is no conflict with the Declaration of Trust papers establishing the OCCIT.
