#### 3. Ceremonies, Proclamations, Presentations

**3a.** Willamette Falls Heritage Area Coalition Update From Alice Norris

Alice Norris, resident of Oregon City, said the Willamette Falls Heritage Area Coalition was the State's first designated Heritage Area and there would be a ceremony at the First City Celebration to acknowledge that.

They were now going-on to apply for National Heritage Area designation, but needed to expand the boundary because the National Park Service was not convinced that the story was complete and significant enough. With adding 12 communities, including from Lake Oswego to Mission Mill State Park, the story was complete and significant enough to qualify.

Both Houses in the legislature passed Senate Joint Resolution (SJR) 10 which directs Congress to designate this area as a National Heritage Area, to reopen the Locks and to add resources to the redevelopment of the Legacy Project. This SJR 10 has not yet been delivered to Congress, but will be soon.

There was a resolution on the City Commission's agenda because the first one was signed in 2011 and it was out of date. She asked that the Commission approve the new resolution to support the congressional request for the National Heritage Area. She explained what led up to include all of the sites up and down the Willamette

River and what additional resources there would be for a National Heritage Area over a State Heritage Area designation.

#### 4. Citizen Comments

Kim Foster, resident of Oregon City, was the Oregon City Community Emergency Response Team (CERT) Program Manager. He was excited to help prepare Oregon City for any emergency disaster. They had monthly meetings at the Fire Station and training was being offered in the community. There was synergy between the various CERT teams and the Willamette Corridor Association to help prepare the community. They were also working on a sheltering plan and were available to help fill in any other gaps.

**6a.** Second Hearing, Ordinance 15-1003, Creating the Downtown Economic Improvement District

Mayor Holladay opened the public hearing.

Eric Underwood, Economic Development Manager, said this was the second hearing for establishment of the Downtown Economic Improvement District (EID). Staff sent notices thirty days prior to the hearing to property owners with the assessed value. Three letters of remonstrance were received and he submitted them into the record.

Jonathan Stone, Downtown Oregon City, was there to answer any questions regarding how they intended to use the EID funds if the Ordinance passed.

Mayor Holladay closed the public hearing.

A motion was made by Commissioner Mengelberg, seconded by Commissioner Shaw, to approve the second reading and final adoption of Ordinance 15-1003, creating the Downtown Economic Improvement District. The motion carried by the following vote:

Resolution No. 15-18, Declaring Oregon City's Election to Receive State Revenues

Mayor Holladay opened the public hearing.

Wyatt Parno, Finance Director, stated this resolution declared the City's election to receive State revenues. Two public hearings were required. The first was held as part of the Budget Committee process on April 13 and there were no public comments. The second hearing was being held that night.

There was no public comment.

Mayor Holladay closed the public hearing.

A motion was made by Commissioner Shaw, seconded by Commissioner Pauli, to approve Resolution No. 15-18, declaring Oregon City's election to receive State revenues. The motion carried by the following vote:

Resolution No. 15-19, Adopting the Budget, Making Appropriations, Imposing Taxes and Categorizing Taxes for the 2015-2017 Biennium

Mayor Holladay opened the public hearing.

Mr. Parno explained this resolution adopted the budget, established the legal spending limits for departments, and set the property tax rate for both years of the biennium. The Budget Committee met on April 13 and approved the budget document that night without any exceptions. The tax rate was 4.4090 per \$1,000 of assessed value. There was one recommended change. As part of the budget process the Commission directed the Police Department to do a comprehensive traffic safety plan. The budget did include one additional Traffic Enforcement Officer. The total budget would be \$165,299,745.00.

There was no public comment.

Mayor Holladay closed the public hearing.

Mayor Holladay said the City made commitments over the last 15 years and continued to live up to those commitments, such as a lower tax rate than what they could be using.

A motion was made by Commissioner Pauli, seconded by Commissioner Mengelberg, to approve Resolution No. 15-19, adopting the budget, making appropriations, imposing taxes and categorizing taxes for the 2015-2017 Biennium. The motion carried by the following vote:

7a. Resolution No. 15-16, Approving a Resolution Calling on the Tri-City Service District and Clackamas County to Change the Governance of the Tri-City Service District

John Lewis, Public Works Director, said this resolution was calling for better governance of the Tri-City Service District. There needed to be a true representation and accountability model. The existing model was outdated and there had been misguided decisions. The only representation was the Clackamas County Board of Commissioners, and none of them lived with-in the District. There had also been problems with getting good, timely information and the District made important decisions on debt, rates, capital improvements, and expansion. This resolution would send a strong message to the County Commission. The governance model Oregon City would like to see was similar to the South Fork Water Board model of equal representation by its member cities.

Mayor Holladay discussed how transparent Oregon City was and how Tri-City was not following those same procedures. The Commission's responsibility was to look out for the rate payers of Oregon City. This was one step to Tri-City being governed

by the people who were in the District.

A motion was made by Commissioner Pauli, seconded by Commissioner Shaw, to approve Resolution No. 15-16, approving a resolution calling on the Tri-City Service District and Clackamas County to change the governance of the Tri-City Service District. The motion carried by the following vote:

Request to Proceed with Relocation of Utilities in Preparation of Library Building Project

Maureen Cole, Library Director, stated the utilities at the site needed to be relocated ahead of the work. Doing it preconstruction was a great way to take advantage of the building season and warm weather. The slide and swing set would have to be removed, and she invited them to the slide farewell party on Saturday. She requested approval to proceed with preparing the site for the building project. The slide would be put into storage and possibly used as public art in the future. The project was over \$50,000 and they would be moving the money around inside the contract.

Will Somme, PNC Construction, explained the cost for the project would be lumped into the overall price, but it would have to be approved in an early work amendment. It was an early allocation of funds.

A motion was made by Commissioner Shaw, seconded by Commissioner Mengelberg, to approve the request to proceed with relocation of utilities in preparation of the library building project. The motion carried by the following vote:
