3a. Resolution No. 17-02, Extending the Declared Emergency and Exempting the Oregon City Retirement Center from Planning Code Requirements on a Temporary Basis

> Tony Konkol, City Manager, said an emergency was declared last week to provide shelter for 16 people due to the extremely cold weather event. There had been a request to extend the emergency due to the continued cold weather that was being predicted through the remainder of the week. This resolution would extend the emergency declaration with the same conditions that were in place previously to expire on January 16, 2017, at 8 AM.

Mayor Holladay asked if the owner was getting paid by the County for allowing people to use the Retirement Center. Mr. Konkol would have to research that information.

Commissioner Mengelberg asked what the process was if the owner wanted to use the facility for this purpose on a regular basis.

Laura Terway, Community Development Director, said the owner would have to go through a Conditional Use process which involved the Planning Commission and public hearings. Staff did tour the site to look at what would need to happen if this was a long term use and found there were access issues and fire sprinkler issues.

Mr. Konkol said parking was also an issue.

Commissioner O'Donnell was not in favor of making this a permanent situation. If it was going in that direction, a lot of considerations would need to be made. He did not have a problem with this on a short term basis.

Jim Band, Police Chief, said there was a group called the Oregon City Homeless Solutions Coalition who was working on forming shelters in the City. They were looking at churches as a possibility and in the future this might not be an issue.

Ms. Terway said currently there were no churches that had a Conditional Use to be a shelter.

Bill Kabeiseman, City Attorney, said if a church was going to add this as part of their ministry, the City would have to look at what sort of restrictions they would be allowed to place on a religious institution's mission.

A motion was made by Commissioner Shaw, seconded by Commissioner Ide, to approve Resolution No. 17-02, extending the declared emergency and exempting the Oregon City Retirement Center from planning code requirements on a temporary basis. The motion carried by the following vote;
