3b. Deed of Dedications and Public Utility Easements on City of Oregon City Urban Renewal Agency Properties, Taxlot 2-2E-29-3000 and Tract A, along Main Street

Aleta Froman-Goodrich, City Engineer, said the Cove Garden Apartments development was approved with conditions to construct Main Street improvements along their frontage and along the frontages of a few Urban Renewal properties. Additional right-of-way was needed for the street improvements and for public utility

easements. There were various deeds of dedication along the Cove Garden Apartments Lot 2, Tract A of the Urban Renewal properties, and Lot 3 of the Urban Renewal properties. The developer would be paying the recording and processing fees. Staff was in support of the design that required this additional right-of-way and recommended approval.
