A RESOLUTION AUTHORIZING ISSUANCE OF OREGON CITY RIGHT-OF-WAY OBSTRUCTION PERMIT NO. RW12-0034 FOR A PORTION OF THE PUBLIC ALLEY BETWEEN JOHN ADAMS AND JEFFERSON STREETS AND 6TH AND 5TH STREETS, OREGON CITY, CLACKAMAS COUNTY, OREGON.

WHEREAS, a right-of-way (ROW) obstruction permit shall be approved by the City Commission for obstructions in ROW with a duration greater than 60 days (permanent obstruction) and

WHEREAS, the Atkinson Memorial Church and its Oregon Preschool, located at 517 Jefferson Street, has received a revocable ROW obstruction permit, Permit No. RW10-0048, per City Commission approved Resolution No. 10-23, that temporarily allowed fencing to be located in the public alley ROW portion between John Adams and Jefferson Streets and 6th and 5th Streets; and

WHEREAS, revocable ROW obstruction permit No. RW10-0048 has expired; and

WHEREAS, Atkinson Memorial Church and its Oregon Preschool, located at 517 Jefferson Street, has requested a new Revocable ROW obstruction permit, Permit No. RW12-0034, for a duration of at least 5-years; and

WHEREAS, Oregon City Public Works Staff confirms that this alley is still constrained by the existence of a private garage and that the continued placement of fencing per RW12-0034 would not further constrain the current public use and accessibility of the alley; and

WHEREAS, this permit, RW12-0034, shall expire 5 years after issuance or may be revoked or extended anytime as determined by the City Engineer due to redevelopment or other reasons; and

NOW, THEREFORE, BE IT RESOLVED by the City Commission of Oregon City that the extension of ROW permit #RW12-0034 be valid so long as the use of the portion of the adjacent property located at 517 Jefferson Street remain as a playground for the duration of this permit.

A RESOLUTION AUTHORIZING ISSUANCE OF OREGON CITY RIGHT-OF-WAY OBSTRUCTION PERMIT NO. RW10-0048 FOR A PORTION OF THE PUBLIC ALLEY BETWEEN JOHN ADAMS AND JEFFERSON STREETS AND BETWEEN 6TH AND 5TH STREETS, CLACKAMAS COUNTY, CITY OF OREGON CITY, OREGON.

WHEREAS, a right-of-way (ROW) obstruction permit shall be approved by the City Commission for obstructions with greater than 60 days duration; and

WHEREAS, the Atkinson Memorial Church and its Oregon City Preschool, located at 517 Jefferson Street, has requested a ROW obstruction permit with a duration greater than 60 days but not longer than during temporary conditions imposed by site reconstruction; and

WHEREAS, the permit request will allow a temporary fence to be located in the public alley ROW between a portion of John Adams and Jefferson Streets between 6th and 5th Streets per City of Oregon City ROW Permit No. RW10-0048; and

WHEREAS, Oregon City Public Works staff has determined that this alley is currently constrained by the existence of a private garage and a utility power pole and that the placement of fencing per RW10-0048 would not further constrain the current public use and accessibility of the alley.

NOW, THEREFORE, BE IT RESOLVED by the City Commission of Oregon City, Oregon, that Resolution 10-23 is approved to allow the issuance of ROW Permit No. RW10-0048.
