3. Adoption of the Agenda

4. Public Hearing

4a. Resolution No. UR17-01, Adopting the Urban Renewal Budget, Making Appropriations and Declaring Tax Increment for the 2017-2019 Biennium

Chair Shaw opened the public hearing.

Wyatt Parno, Finance Director, stated this resolution would adopt the biennial budget for Urban Renewal and declare the tax increment to be the maximum tax rate. The Budget Committee met on May 10, 2017 and the proposed budget was approved without any exceptions. Staff recommended approval of the resolution.

Commissioner O'Donnell confirmed that the budget honored the current state of affairs and its goal was to service the existing debt. Mr. Parno said that was correct.

5a. Purchase and Sale Agreement for 922 Main Street

Eric Underwood, Economic Development Manager, said a purchase and sale agreement had been put together for 922 Main Street as directed by the Urban Renewal Commission in May. The agreement was with Willamette Stone Partners LLC for the development of a mixed use building that would consist of ground floor retail and three levels of residential. The sale price was \$110,000 and there would be a parking component. Construction would start within 60 days of approvals and be completed within two years.

A motion was made by Commissioner Ide, seconded by Commissioner Mitchell, to authorize the City Manager to execute the purchase and sale agreement with Willamette Stone Partners LLC for 922 Main Street. The motion carried by the following vote:
