A TRACT OF LAND BEING ALL OF LOT 1 AND A PORTION OF TRACT "C", "LANDS END", A DULY RECORDED PLAT IN CLACKAMAS COUNTY PLAT RECORDS, LOCATED IN THE SE 1/4 OF SECTION 8, T. 3S, R. 2E, W.M., CITY OF OREGON CITY, CLACKAMAS COUNTY, OREGON, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:
