#### NW Natural's Low Carbon Pathway Presentation 3a.

Nina Carlson, Local Government Affairs Liaison for NW Natural, gave a presentation on NW Natural's Low Carbon Pathway program. She discussed the low carbon future, NW Natural's starting point, goal of 30% carbon savings by 2035, methane recovery efforts, efficient products for customers, renewable natural gas for transportation, and marketing campaign.

The Commission asked questions about the program.

#### **Citizen Comments** 4.

Tom O'Brien, resident of Oregon City, handed out brochures that promoted tours in Clackamas County and discussed them.

Bob Mahoney, resident of Oregon City, thought the Commission was there to serve

and help solve the public's business.

William Gifford, resident of Oregon City, announced the Oregon City Business Alliance was presenting a two part series on the subject of growth.

# 6. Public Hearings

First Reading of Ordinance No. 18-1010, Remand of Land Use Board of Appeals Court Decision for Planning Files PZ 15-01: Comprehensive Plan Amendment and ZC 15-03: Zone Change Located near Beavercreek Road and Highway 213 (Tentative Decision)

Mayor Holladay opened the public hearing.

Carrie Richter, City Attorney, read the hearing statement. She asked if any Commissioner had ex parte contacts, conflicts of interest, bias, or statements to declare including a visit to the site.

Commissioners Shaw and Mengelberg visited the site.

Laura Terway, Community Development Director, presented the staff report. This was a remand from LUBA regarding a zone change for a site near Beavercreek and Highway 213. The City was to consider only one issue, whether development allowed by the proposal conflicted with the Goal 5 protected resource on the property, which was Newell Creek. She explained how Newell Creek was protected through the Natural Resources Overlay District and stormwater and grading design standards. Both staff and the Planning Commission concluded that the City's regulations were adequate to protect Newell Creek with the zone change.

The Commission asked clarifying questions about the application.

Garrett Stephenson, representing the applicant, explained the Commission had to determine whether or not the City's existing protections of Newell Creek were sufficient given the new zoning. He discussed why he thought they were. The only difference with the new zoning was a little more impervious surface with a higher density commercial product, which would be mitigated through stormwater facilities that were large enough to handle the run off. He addressed the issues that were raised about protections for the creek, pollutants, and how the City's standards implemented Goal 5.

Mayor Holladay closed the public hearing.

Ms. Richter reviewed the findings in the staff report and clarified that portions of the Spady letter were beyond the scope of the remand.

A motion was made by Commissioner Ide, seconded by Commissioner Shaw, to approve the closure of the record, re-approval of Planning Files PZ 15-01: Comprehensive Plan Amendment and ZC 15-03: Zone Change located near Beavercreek Road and Highway 213, and approval of the first reading of Ordinance No. 18-1010 with revised findings to be adopted during the second reading of the ordinance on August 1. **7a.** Contract for Project Management and Owner's Representative Services for the Police and Municipal Courts Building

Jim Band, Police Chief, requested approval of the contract for \$480,000 for the project manager for the new police building project. Next month he would be requesting approval of a contract for an estimated \$1.5 million for the architecture firm. He gave the project planning history, project considerations, programming adjustment from the technical advisor, and next steps.

There was discussion regarding the challenge to keep costs low due to the current market, the need to have flexibility in the design and to build it with efficiencies to reduce ongoing operating costs, and creating a building that would have enough capacity for 50 years.

William Gifford, resident of Oregon City, thought this building would be a statement about their community and a legacy. He encouraged the City to look into materials that were locally made and produced.

A motion was made by Commissioner Shaw, seconded by Commissioner Ide, to approve the contract for project management and owner's representative services for the police and municipal court building. The motion carried by the following vote:
