# **BACKGROUND:**

- Building built in 2016
- Petra operated the building as a memory care community for ~6 months
- Bldg. been vacant ever since
- New team:
  - New Architect
  - New owner (Jeffery) finishing up purchase of the property
  - o New management company very experienced in senior care

# OUR WORK:

- Bldg. will continue to operate as a memory care community serving residents in need in Oregon City
- Improve ADA accessibility
- Improve lighting to meet licensing requirements
- Work to commence within 30 days on mostly interior work while we process the land-use application to add residents
- Building reopen about the end of February 2019
- Adding 1 unit
- Extending 6 other units to accommodate double occupancy
  - o 38 total residents
  - o Still maintaining set-backs on north and south sides
  - Existing 6' sight obscuring fence to remain on north side
  - Shifting exterior HVAC units to beside the unit expansions
    - Will not be any closer to property line than they are now
    - Fans will now face sideways, not towards adj. property

A 10 minute presentation was given to roughly 40 attendees at the beginning of the evening and then a question period was held.

During the question period attendees were curious about:

Questions regarding the number of residents, type of facility, and when the facility will open

Concerns were raised about the proximity of the building to the North property line. This was discussed that it was within setbacks and that the existing mechanical units will be moved to not face the property line to mitigate sound.

Questions were raised about the drainage of the site.

The political sign placed on the site was concerning to attendees.
