Per your request from December 20, 2018 for the call data for the Rivercrest Neighborhood for January 1, 2014 through current, I was able to obtain this information.

The Rivercrest Neighborhood is in Police Grid 5, so I requested that the information be sorted by street and park to include Brighton, Creed, Park, Promontory and Rivercrest Park. I have also included the three photos of graffiti that you requested from the bluff area.

The information is broken out by Property Crimes, Person Crimes, Behavioral Crimes, Traffic Calls and Misc. Calls. The first column of numbers is a combined total from January 2014 through Current. The next column is calls broken out for 2018 and the last is for 2014-2017 together.
