To whom it may concern

I am writing in regards to the proposal to levy an annual \$5000.00 permit fee on facilities that provide temporary warming for the homeless in terms of grouping them together with shelters. I most vigorously protest this notion as it

will make providing this service cost prohibitive for most warming centers and significantly increase mortality and morbidity in this very susceptible population. As President of the Medical Staff at Providence Willamette Fall Medical Center, I am constantly made aware of the crush of care that we must provide during the Winter for patients who contract influenza and respiratory infections and any change in our community dynamic could significantly diminish our already stretched resources.

Please reconsider your position on this issue so that we can continue to reduce human suffering and keep our medical facility available to patients who need care and we don't have to treat patients who by having access to a warming facility will not need our services.
