We will definitely work towards a solid plan to move this project forward with taking the 30% plans, hiring a consultant to design the 100% plans, then go out to bid for construction in the year 2020-21 fiscal year.

The project can be designed to 100% Plans with the grant extension request being approved by the Grant Committee.

With the Biennial Budget 2019-2021 officially approve, the design phase budget is \$25,000 Metro Enhancement Grant plus the \$60,000 Stormwater Fund for fiscal year 2020 (July 1, 2019 thru June 30, 2020). 





Dear Lori,

As per our telephone conversation today, the Oregon City Parks Foundation (OCPF) is requesting another six month extension for our 2017 Metro Community Enhancement Grant through the fall of 2019. In partnership with the Oregon City Parks Department, we have contracted with R. Franco Restoration to apply spray on nine acres of Waterboard Park for invasive English Ivy.

The spraying has to be done in a specific window of time in the spring or preferably the fall, with two follow up sprays, to completely eradicate the ivy. We were able to spray nine acres in the spring of 2018 with and again in September. Another four acres was added, adjacent to the nine acres and sprayed in October 2018.

Due to the number of spray applications needed and specific window to spray, we were not be able to complete our project in the Grant timeline. Therefore we are requesting another extension through fall of 2019 to finish up the spraying of 13 acres in this park.

We hope you will consider approval of our request for an extension of our grant.
