The Clean Team project is daily ongoing and will conclude in June 2019. The Elevator Kiosk has been fabricated and is ready for installation pending approval from the City Public Works team.

5. Briefly describe the project for which you are requesting funds.
Placemaking in Downtown Oregon City includes activating both public and private spaces in downtown on a more regular basis to make Downtown Oregon City a destination for the community and visitors alike. Creative Placemaking is an evolving field of practice that intentionally leverages the power of the arts, culture and creativity to serve a community's

interest while driving a broader agenda for change, growth and transformation in a way that

also builds character and quality of place. Placemaking is community-driven, visionary, adaptable, inclusive, focused on creating destinations, context-specific, dynamic, trans-

disciplinary, transformative, flexible, collaborative, and sociable.

Downtown Oregon City Association already does placemaking with events like First City Celebration and projects like the Street Tree Lights or façade improvement projects. However, to really create a place that people want linger longer in, DOCA would like to activate our public spaces more often and in a more targeted and engaging way.

This grant would support DOCA's capacity to put together 20+ new projects, programs, and events in Downtown Oregon City to create a sense of place and belonging for the greater community. Projects will include weekly activities like Yoga in Liberty Plaza or a flower market; events like a video game competition and/or B-movie nights; creative public art projects like popup art galleries or theater performances; engaging and creative self-directed projects like simple street furniture or a chalk art day; and civic engagement projects like community clean ups, Earth Day celebrations, etc.

The direct result of these placemaking activities will engage the community, increase foot traffic, enhance engagement in public art and culture, increase eyes on public spaces which increases safety, increase recreational activities in downtown, and increase community pride. The indirect impacts of placemaking activities are more community ownership of the space which often leads to cleaner spaces, increased property values, and improved safety.

6. Describe why this project was selected and the community need(s) to which it will respond.

Downtown Oregon City Association has worked on revitalizing Downtown Oregon City for 10 years – the first five years were dedicated to beautification projects to make a beautiful downtown; the second five years has been dedicated to branding, marketing, and business recruitment. Now that we have a national award-winning downtown product that we can be proud of, we need to build a community following including regular community support of local businesses as well as an engaging place for visitors to our community.

DOCA has been working with Clackamas County to prepare for the eventual relocation of the Courthouse. Using DOCA's pedestrian counters, there are an average of nearly 800 visitors a day to the Courthouse and we need to start working now to begin to replace that foot traffic to avoid a significant impact to the downtown businesses. DOCA has identified placemaking in downtown public spaces as the first step in supporting the Courthouse relocation.

- 1. Upon receiving this grant, we will begin planning a fall community cleanup as well as an Earth Day cleanup. These two placemaking projects will directly improve the cleanliness and beauty of downtown. The indirect result of several placemaking projects is community pride and ownership which have been proven to result in more conscious behavior from the community.
- 3. There are really only two things that make property valuable: quality of the space and location. While we can't increase the quality of the private property with this grant, we can increase the value of the location. By increasing foot traffic, pride, and ownership in the downtown, we can increase the value of all of the public and private property. Over the past ten years, our work to revitalize Downtown has increased property values nearly tenfold. With continued placemaking efforts, we will continue to attract new and exciting businesses, increase property values, and beautify Downtown Oregon City.
- 6. There are a minimum of 20 different programs and multiple spaces within our downtown that we hope to activate to help people enjoy their experience in Oregon City.
- 7. When designing public spaces, there is a concerted effort to make them visible by multiple angles to "increase eyeballs" on the space for safety sake. Just like dark out of the way spaces tend to be unsafe, unused or underutilized public spaces are less safe than active spaces that have multiple uses over various times of the day. DOCA plans to activate public spaces on a regular basis, various times of day and days of week. This will result in a safer downtown.
- 8. Placemaking is a tool used by economic development agencies to recruit new business, encourage entrepreneurship, and retain and expand existing businesses. These activities will increase foot traffic and spending in Downtown Oregon City. Increased spending and sales downtown mean that businesses will need to staff up accordingly.
- 10. Placemaking activities will include public art projects like outdoor theater performances, small band concerts, films, popup "art galleries" and interactive art projects.

9. What is the geographic area of Oregon City where the project will take place?

Downtown Oregon City from 99E to 15th Street.

10. How will the community benefit by your project? What is the estimated number of people affected and anticipated outcome(s)?

The community will be the primary beneficiary of placemaking activities along with the 200 businesses in Downtown Oregon City. The community will benefit through activities that they don't have to leave Oregon City for – community pride that there are regular activities to participate in. In 2018, our pedestrian counters counted 19,500 participants in our 6 events. In 2019-2020 we hope to hit 50,000 participants with 20+ new placemaking projects. Anticipated outcomes for the placemaking activities include increased attendance, increased sales at local business, and new businesses with more active uses.

11. What community resources will be used as support for this project (i.e. community, cityowned property, city departments, transportation services or other civic groups)?

The majority of the placemaking activities will take place on County property at Liberty Plaza and in public right-of-way owned by the City. We will also use private spaces for some of these activities. These placemaking activities could not happen without support from volunteers, community partners, the County and the City. Existing projects include things like First City Celebration which is an all day event that requires police, barriers, street closures, etc. But the new projects associated with this grant will be smaller, more targeted events and placemaking activities that will not require the herculean efforts of a major street fair.

12. Briefly describe prior experience managing similar projects, including any past enhancement projects.

DOCA has successfully managed several Enhancement Grants over the past 5 years as well as multiple tourism related grants, heritage grants, Oregon Main Street revitalization grants, and façade improvement grants. We have a record of success for all of the grants that we have received. We have also learned from them and make each project that we take on easier to manage with better tracking metrics.

Anticipated milestones include hiring an events and placemaking manager, determining what projects are viable (with the County judges), regular task force meeting, and each project or event over the course of 1 year.

Goals for this project include increased attendance and foot traffic, increased sales at local businesses, increased property values and rent levels. We also want to encourage new forms of transportation as well.
