## **Meeting Minutes**

#### 1. Call To Order

Acting Chair Jon McLoughlin called the meeting to order at 7:00 PM.

3. Electronic Messaging Policy Explanation

Kattie Riggs, City Recorder, provided an overview on email and records management. She provided the definition of a public record and explained how it applied to the Historic Review Board.

Legal Training with Carrie Richter, Assistant City Attorney

Carrie Richter, Assistant City Attorney, provided legal training on Oregon land use, the Comprehensive Plan and City Code, public hearings, and Historic Review Board decisions.

Design Advice: New construction on a residential site in the Canemah National Register District.(4th Avenue between Apperson and Blanchard)

Kelly Reid, City Planner, stated that the site was a 50' x 100' vacant lot adjacent to the AE Davis residence, a contributing historic structure in Canemah. The proposal included a residential structure with a detached garage and living quarters above the garage. The home proposed was a vernacular style, 1 ½ stories, with a front porch and double-hung windows. Ms. Reid didn't foresee any issues with the style of house proposed but sought guidance from the Board on the side yard setback from the AE Davis residence which was the required five foot minimum. She also sought input on the appropriateness of the accessory dwelling above the garage.

Jon McLoughlin commented that the proposed house looked similar in style to the AE Davis residence.

Ron Bistline, resident of Oregon City, said that he lived adjacent to the site and the proposed house was for his daughter who currently lived across the road from the site.

He explained the differences between the proposed house and the AC Davis House and addressed the setbacks.

Mr. McLoughlin indicated that he found the proposal to be acceptable and the other Board members didn't express any concerns.

Ms. Reid noted that she would make carriage garage doors a condition of approval.

#### **6.** Minutes
