Dave Anderson, resident of Oregon City, did not like fees. Chief Band had explained it to him, but it was still a fee and he was not in favor of it. He thought other options should be explored. He was glad to hear that a Park Foundation might be created. He asked Mr. Lewis where the \$2,500 he paid for Thayer Pond went.

Mr. Lewis would get back to him with an answer. Mayor Holladay said the Community Safety Fee was the best way to spread out the fee to everyone. If it was a bond, it would not include the County or schools. Everyone used public safety and everyone should have to pay for it.
