## **Regular Meeting**

- 1. Call to order at 7:14pm
- 2. Introductions
- 3. Approval of minutes June 22, 2017 Meeting Minutes

Moved by Doug Neeley, seconded by Shawn Dachtler. Approved unanimously.

- 4. Citizen comments on issues and items not on the agenda
  - a. Tom O'Brien thanked everyone for coming to the Filbert Run volunteer cleanup event. Noted that North Clackamas Parks & Recreation District was advertising their Movies in the Park events at the Oregon City Burgerville location and suggested that Oregon City Parks look into expanding our marketing area.
- 5. Presentations
  - a. Presentations McLoughlin Promenade Wall Cap Replacement Project
     Phil Lewis presented information on an upcoming project to make repairs to the
     McLoughlin Promenade wall caps. Work will occur in Fall 2017 and is being funded
     through a Community Enhancement Grant and City funds.
- 6. General Business

- a. Carnegie Library Park As requested by PRAC, Phil Lewis attended the July McLoughlin Neighborhood Association meeting to inform the neighborhood of the proposed name change of the park from Carnegie Library Park to Carnegie Park. Neighbors were generally supportive but requested more notification to the public regarding any future name changes on public parks. Phil will attend the CIC meeting on August 7, 2017 and will present on the name change at that meeting.
- b. McLoughlin Canemah Trail This coming Saturday, July 29<sup>th</sup> from 9am-1pm, the City will be hosting a "Greenway for a Day" event at locations between the McLoughlin Promenade and Canemah Children's Park. The event will showcase proposed routes for the trail and staff will be available to answer questions and receive feedback. An ivy pull event will be hosted at Old Canemah Park from 9am-11am as part of the event.
- c. Willamette Falls Legacy Project Transportation Planning meeting #3 occurred July 26<sup>th</sup>. The meeting was a wrap-up on the previous meetings and general recommendations for transportation options relating to the Willamette Falls Legacy Project. Public comment is currently open on the Oregon City website.
- d. Dog Off-Leash Areas A draft version of an online survey was distributed to committee members. Suggestions for alterations were received from members. Distribution methods for the survey were discussed.
- e. Latourette Park Planning & Phase 1 Development The Latourette Park Core Team applied for and received a Community Enhancement Grant of \$25,000 to make improvements at Latourette Park. Phase 1 improvements include removing asphalt from the upper park and installing a small nature play area, moving the basketball standards from the upper park to the lower asphalt area. Partners on the project include DePave, CAIS, OCHS and National Park Service. A public engagement event is scheduled for September 10<sup>th</sup> from 3-5pm with live music by Big Yellow Taxi. Asphalt removal is anticipated to begin in Spring 2018.

- 7. PRAC Member Reports

Roger Fowler-Thias: Pioneer Center has been working on improvements to the grounds. Landscaping on the corner of John Adams & 6th have been cleaned up to allow for more visibility. The pathway project has been well received. The volunteer recognition event is scheduled on August 24<sup>th</sup> and will be managed by pool staff Melissa this year.

Mike Mitchell: Parks Foundation met Monday evening and received a couple of grants including ivy removal project at Waterboard Park which will require a substantial number of volunteer hours. The second grant was received from the Hardy Plant Society for plantings at Pioneer Center and McLoughlin Promenade/VFW.

Shawn Dachtler: No comments, but asked Roger Fowler-Thias and Mike Mitchell what the amount of money received from the two grants that were awarded to OCPF. Mike stated that the Hardy Plant Society grant was less than \$500 and the Community Enhancement grant was for approximately \$19,000.

Joyce Gifford: "Drop in for Parks" is occurring at Concerts in the Park. OCPF has been receiving approximately \$100 per week through bottle donations.

Doug Neeley: Greater Oregon City Watershed Council has worked at Abernathy Park to remove invasive plants and replant. Snowberry was replanted this past spring and is now full of neddles. Doug noted that follow ups are required. GOCWC is also involved in the salvage operations at the environmental learning center at Clackamas Community College. The ponds will be improved.

Lisa Novak: Attended the first of a series of McLoughlin Canemah Trail planning meetings. Will also attend the Saturday "Greenway for a Day" event. Attended a couple of the Concerts in the Park events. Gave kudos on the events and thanked the staff involved in organizing.
