She described the subject site, existing zoning, and layout as well as the Metro boundary change criteria, annexation criteria, and zone change criteria. Staff and the Planning Commission recommended approval with no changes to the staff report.

Joey Shearer, planner with AKS Engineering, was representing the applicant. He supported the conditions and findings in the staff report. He thought all of the criteria had been met.
