### **BACKGROUND:**

A comprehensive public process has resulted in many community discussions and recommendations to City staff for revisions to the signage standards. Planning Commission Work Sessions were held on February 24, 2014 and March 24, 2014 and a public hearing was held on April 14, 2014 before the Planning Commission providing background on the public involvement process related to the sign code update and the proposed code language.
