Two Appeals of Planning File SP 14-01- Beavercreek Road Live/Work Apartments (Planning Files: AP 14-01 and AP 14-02).

RECOMMENDED ACTION (Motion):

Staff recommends the City Commission deny the two appeals, one filed by the applicant, Beavercreek Road LLC, AP 14-01, and one filed by Elizabeth Graser-Lindsey, AP 14-02, and uphold the Community Development Director's decision to conditionally approve the application.

BACKGROUND:

This item was continued from February 4, 2015.

SP 14-01 is an application for Site Plan and Design Review for a 121-unit Apartment complex and 59 Live-Work Units on 9.7 acres (Zoned MUC-1). The Community Development Director approved the application as a Type II Limited Land Use decision on November 14, 2014.

AP 14-01 is an appeal by the Applicant regarding Condition of Approval #37.

AP 14-02 is an appeal by Elizabeth Graser-Lindsey for various reasons.
