BACKGROUND: The City received an application for a Concept (Master) Plan Amendment, Detailed Development Plan, Natural Resource Overlay District Review and a Geologic Hazards Overlay District Review request for construction of Phase 1 of the Cove development, located near 16400 Main Street. In addition to amending the previously approved Concept (Master) Plan, Phase 1 generally includes construction of 244 multi-family units as well grading along the water. This work session provides an opportunity for the public to hear an in-depth explanation of the application prior to a public hearing. No public testimony will be heard.
